#### **State of the Borough Message: Mayor LaBarbiera**

Thanks to everyone for coming to the 2018 Reorganization Mayor And Council meeting. 2017 was another very busy year and Mayor LaBarbiera is confident that the administration, Borough employees, and volunteers all worked to accomplish our goals. As good of a shape we were in last year Paramus is in an even better place then it was one year ago. Mayor LaBarbiera continues that this is his 8<sup>th</sup> State of the Borough address and he likes to reflect on the past year and talk about the coming year and what we will accomplish. 2017 was a great year for the Borough of Paramus. In January we started with a new mobile command center for the Office of Emergency Management. Rising Paramus musician Jake Fisal traveled overseas and played for Bruce Springsteen's Charity Light of Day Foundation. Paramus was ranked number one in Bergen County and number 10 for the State for recycling which landed us a recycling Grant. Amazon announced the opening of its first New Jersey store in Paramus. We completed new pedestrian safety programs at various crosswalks by schools with Led lights. GSP announced a makeover. Valley Hospital announced they will be moving from Ridgewood and will be building a brand new state of the art hospital in Paramus. In February we received a visit from the Vatican. Councilman Verile and Rec Commissioner Gary Sisman took a swim at Seaside for the Polarbear plunge. The Harlem Wizards took on Borough employees. In March our very own Detective Sargent Jimmy Teehan was named New Jersey Lead Officer of the Year. We participated in Read Across America and we continued to work on the deck at the Senior Center. Now Paramus Alumni wrestler competed in the States. Our fifth annual weight loss challenge kicked off. Frisch High School Varsity basketball team won National Jewish High School Tournament and was ranked number one in the Country. DPW and Shade Tree conquered challenging storms conditions. PHS hosted a stem competitions that brought schools from all over the State. In April Chick Filet changed hands, we kicked off Little League with the pancake breakfast. Paramus Sunrise Rotary had their annual Fashion Show. Rec hosted their annual Easter Egg Hunt. The Library renovations were completed. Councilman Verile was named Rec 2017 Coach of the Year and congratulates him. Our PD and DEA came to Paramus and hosted Opioid concerns for teens. Expansion Fire Department number two kicked off with demolition. Our Little League kicked off the annual season with a parade. We had our annual Earth Day Celebration. In May the PD launched a heart program for drug users. Paramus Park added Mr. Cupcakes. Shade Tree came to the rescue when a tree fell on the Senior Housing Complex. The poetry contest returned back to the Library. Our residents and athletes enjoyed the renovations to the fields and facilities. In June Recreation hosted its annual Spring Fling. Various changes and improvements to the Pool were finally showcased and a great job to all involved. Our Farmers Market returned to town again. The Library hosted Book New Jersey 2017. Our PD participated in a German Exchange Program. Paramus lost longtime resident Dr. Selma Mitchell. In July we had another great Fourth of July, including

the parade that was attended by our next Governor Phil Murphy, fireworks and the annual PD/Fire Department softball game that was won by the Fire Department. Mayor LaBarbiera thanks the Fourth of July Committee. Our Tuesday Summer Concert Series kicked off. Farview saw improvements and paving thanks to the County. The Forum Diner was demolished to make room for the construction of I-Fly. Our District team won District four title. Our Fire Department won the Softball League Championship for the first time in sixteen years. The Paramus Pacers won there dual meet. In August we had another successful National Night Out. Our Fire Department had a very busy August with many house fires. In September, Paramus residents Patrick O'Connor and Rick Takihasi went off for training in the Marine Core. Ed Hill and Boy Scout Troop 138 ran Hurricane Relief collection. In October the Fire Department visited all elementary schools for Fire prevention month. The Paramus Run was again a success. We celebrated Halloween with a party at Fire Department and Rescue building. The PD was featured on ABC News for Police investigation and Bill Clinton came to town for a short campaign visit. In November The Paramus PBA members were deployed to Puerto Rico for relief efforts and we held several Veterans Day ceremonies. We hosted an active shooter drill at the Garden State Plaza. Stew Leonard's is coming to town in the old Sears building. Paramus High School athletic Hall of Fame welcomed inductees. We received a Cops Grant from the Federal Government that allowed us to hire five new Police Officers. In December we kicked off the season with another Winter Wonderland and thanks Dennis Arslanian. The Rec hosted there annual holiday party at West Brook. We hosted Pearl Harbor luncheon with World War Two Veterans. Our Senior Center had a holiday party and Borough Hall had a toy drive. The Fire Department treated the residents to their traditional Santa detail. Maryann Uzzi was recognized for her efforts with Stigma Free annotative and received a home town hero award. Our Paramus PD also had a toy drive and Gold's Gym celebrated their 25<sup>th</sup> anniversary. Petruska Park started construction of its first ADA Playground. The High School put on their holiday concert. We lost long time employee Chrissy Pappas and we will miss her in 2018. Through the efforts of our PD we have had a reduction in crime and Mayor LaBarbiera thanks PD and Chief. The three yearlong Parkway Project is coming to an end. For the seventh year in a row there is isn't an increase in municipal taxes and we are maintaining a surplus that we have grown earning us a triple bond rating that we have maintained for two years now. Once again the bar is pushed even higher as we enter the New Year but rest assured as in years past we will not disappoint. Mayor LaBarbiera says this is his 14<sup>th</sup> year as elected official 6<sup>th</sup> as a Council person and 8<sup>th</sup> as Mayor. Last year he spoke about the preceding three years being plagued with negativity and putting one selfish political agenda ahead of the residents of Paramus which included attempts to discredit policies and programs that are good for the residents all in effort of political gain. Most of that is almost gone regretfully some remain in 2017 but he is hopeful that in 2018 that cloud of negativity will be gone. As he said last year the responsibilities of your elected officials are very real. We govern and oversee a Municipality with many employees and residents with a \$58 million budget, 27,000 students and commercial properties that bring in more sales tax than any other in the Country. We have an \$8.4 billion tax base and hundreds of thousands of visitors. Last week one mall alone received a record 190,000 visitors in a single day and even with all those visitors Route 17 was quiet. Thanks to a solid Council majority Paramus has enjoyed a period of unmatched prosperity and success. This is supported by the almost 800 Resolutions and Ordinances that were voted on last year, all were unanimous with only the exception of two no votes. This means that this governing body is doing something right and an exceptional job in his opinion if the Council agrees and votes with each other. Mayor LaBarbiera continues that he looks forward to 2018 for many reasons. One of which is in hope that the remaining cloud of negativity moves on, we improve on those two no votes, create an even more constructive environment and we continue to make decision solely on what is in the best interest of the residents of Paramus. Some of the things we can expect to see in 2018 are major renovations at the Senior Center, a new fire truck for Company 3, additional shared service agreements, continued improvement and expansion of Borough services, traffic review , improvements to the golf Course including a new 50's themed ice cream stand, the return of the Barclay tournament in August, following through on a recommendation from Councilwoman Tedesco-Santos to increase stipends for our volunteer fire and rescue, and making acting promotions in

the PD permanent. The budget will again be challenging and even more in light of the tax bill and we are already working on a plan that the details will be announced in the coming days. We will take it head on and he can say with certainty that there will not be an increase in Municipal taxes this year and for the 8<sup>th</sup> year in a row. With the New Year he can't help but be optimist with the new Council about what the future holds for Paramus. He wishes everyone, employees, volunteers, the Council, Councilwoman Bellinger and Councilman DiPiazza a very successful 2018. Paramus remains to be the place to be for families, business and retail. Mayor LaBarbiera thanks everyone for the opportunity to deliver his 8<sup>th</sup> State of the Borough address and does not plan on it being his last and will see you next year to tell you about the great things of 2018. Here's to a successful 2018 and God Bless Paramus and America.
