Letter to resident from Mrs. Migliaccio informing that since Mr. Linden was bitten by his dog and it is strongly recommended that he receive post-exposure treatment to ensure that he will be protected from becoming infected with rabies.

Letter to Mrs. Migliaccio from Hansel Asmar requesting her approval to grant the BCDHS access to view Communicable Disease Reporting and Surveillance System (CDRSS) cases within our jurisdiction.

Press sent out "BOH Offers Seasonal Flu Vaccinations" on September 29th.

STAFF REPORTS

Mrs. Migliaccio briefly reviewed the report for the month of July and August.

The nurses continued their adult health assessments, taking blood pressures, counseling, follow-ups and Mantoux testing for EMS members.

We held several programs this summer such as: Skin Cancer Screening at the pool on July 11th, National Night Out, Blood Chemistry Screening Program and the upcoming Flu Immunizations.

The Environmental staff had 233 food establishment inspections and 45 complaints for June, July and August. They also took pool samples during the season to make sure it was always safe for swimming.

They also oversaw the PGA Tournament August 21st through the 26th.

They remain extremely busy with all of the temporary events happening since the change in procedures by the Borough Clerk's office.

Animal Control remains busy with 59 calls taken and 60 animals handled in June, July and August.

Several summonses were also issued for a variety of Foodhandling violations.

Finally, our statistical and financial monthly reports for June, July and August resulted in us taking in over \$130,000.00 in total receipts.
