**AN ORDINANCE TO AMEND CHAPTER 419
TITLED "VEHICLES AND TRAFFIC"**

AN ORDINANCE TO AMEND the Code of the Borough of Paramus, by amending Chapter 419-47 Schedule V: Prohibited Turns at Intersections. §419-50 Schedule VIII:Stop Intersections; §419-59 Schedule XVII:Parking prohibited Certain Times; §419-56 Schedule XIV:Parking prohibited At All Times; and Crosswalks

BE IT ORDAINED by the Mayor and Council of the Borough of Paramus as follows:

Section 1. Chapter 419 of the Code of the Borough of Paramus is hereby amended by amending Chapter 419-47 Schedule V: Prohibited Turns at Intersections. §419-50 Schedule VIII:Stop Intersections; §419-59 Schedule XVII:Parking prohibited Certain Times; §419-56 Schedule XIV:Parking prohibited At All Times; and Crosswalks by the addition of the following: Schedule attached hereto:

Section 2. If any part of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 3. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed or amended to the extent of such inconsistency.

Section 4. This Ordinance shall take effect upon final passage and publication according to law.

§ 419-50. Schedule VIII: Stop Intersections.

In accordance with the provisions of § 419-10, the following described intersections are hereby designated as stop intersections, and stop signs shall be installed as follows:

#4 Add prohibition of parking during certain times for Gerald Street.

§ 419-59. Schedule XVII: Parking Prohibited Certain Hours.

In accordance with the provisions of § 419-22, no person shall park a vehicle between the times specified upon any of the following described streets or parts thereof:

#5 Change prohibition of parking during all times for northern end of Roosevelt Blvd.

§ 419-56. Schedule XIV: Parking Prohibited at All Times.

In accordance with the provisions of § 419-19, no person shall park a vehicle at any time upon any of the following described streets or parts thereof:

The locations described in Schedule xxxxxxxx, attached to and made a part of this chapter, are hereby designated as crosswalks.

§ xxxxxxxxxx SCHEDULE xxxxxxxx: CROSSWALKS.

In accordance with the provisions of § xxxxxxxxxx, the following listed locations are hereby designated as crosswalks:

Century Road

- a. 500 feet west of Spring Valley Road, mid-block adjacent to Paramus High School

Midland Avenue

- a. 90 feet west of Willard Road, mid-block adjacent to Memorial School
- b. 900 feet east of Paramus Road, mid-block adjacent to Midland School

Farview Avenue

- a. 600 feet north of Broad Avenue, adjacent to Yavneh School
- b. 400 feet south of Fairmount Place, adjacent to Paramus Fire Co #4
- c. 50 feet south of Wyoming Road, adjacent to Our Lady of the Visitation Church

East Ridgewood Avenue

- a. 560 feet east of Farview Avenue, mid-block adjacent to the Bergen County Complex

Essex Road

- a. 470 feet south of Century Road

Green Valley Road

- a. 250 feet east of Tuers Lane

Spring Valley Road

- a. 850 feet north of Century Road
