**ORDINANCE AMENDING ORDINANCE 18-25 AMENDING
PARAMUS CODE § 259 PERTAINING TO GOLF FEES**

Section 1. Purpose & Authority. Pursuant to N.J.S.A. 40:48-2, 40:49-2, and 40:61-22.9, the Paramus Governing Body hereby amends Section 259-5 of the Paramus Code to set the golf fees for 2020.

Section 2. Golf Fees. Effective January 1, 2020, the fees set forth in Section 259-5 of the Paramus Code shall be amended as set forth:

Seniors (62 +) & Juniors (17 & under)
 - **Twilight Rate:** 2 hours prior to closing – Discount of regular rate: - Non-resident - \$ 10 --- Resident - \$ 5.
 - **Replay Rate:** 2nd 18 holes on same day - Discount of regular rate: - Non-resident - \$ 10 --- Resident - \$ 5.
 - **Holiday Greens Fees:** Same as Weekend Rates.
 - **Motorized Golf Cart:** 18 hole fee - \$ 34 - 9 hole fee - \$ 17 - **Hand Carts:** \$ 5

EVENING LEAGUES: Mon. to Fri. -**\$28** per 9 hole round (cart - \$9 per golfer) Pull cart \$3/nine holes

MINI GOLF: Adults: \$ 8 Children/Seniors: \$5 Group Outing: \$150 Fee + \$4 per person

OUTINGS: Non Paramus Groups - \$95/ Paramus *Civic, Fraternal, or Religious Groups - \$75
Fee includes greens fees, cart, prizes, range balls, scoring & snacks – (includes \$6 fee to be paid directly to the restaurant.

Veteran Discounts

All pro shop merchandise an additional 10% off member prices-Proper ID required

Active Military Play for free including cart rental- Proper ID required

Mini Golf- Active Military play for free - up to four (4) players – Proper ID required

Section 3. Repealer. All prior ordinances that are inconsistent with this ordinance are repealed. All ordinances are hereby amended to be consistent with this ordinance and all ordinances, including this one, shall be construed consistent with the express purpose of this ordinance.

Section 4. Savings and Construction. This ordinance shall be construed consistent with the purpose stated in section 1 hereof. Any ambiguities in this ordinance shall be construed in accordance with the purpose of this ordinance. If any part of this ordinance is invalidated by a court of competent jurisdiction, the remainder of this ordinance shall be saved to the full extent possible. This ordinance repeals provisions of the Paramus Code only where stated herein; otherwise this ordinance is amendatory and supplementary to existing provision of the Paramus Code.

Section 5. Effective Date. This ordinance shall take effect immediately upon approval and publication of notice of adoption as provided by law.
