**ORDINANCE CREATING NEW TITLE AND UPDATING JOB  
DESCRIPTION AND SALARY SCALE**

Section 1. Purpose & Authority. The Borough of Paramus hereby adds the following title as a part time/seasonal employee.

Section 2. New Title: The following title is hereby created:

**GOLF INSTRUCTOR**

Section 3. Job Description. The job description for the following title is hereby created. The Golf Instructor shall provide golf lessons at times that do not conflict with other activities taking place at the golf course.

Section 4. Pay Scale. The rate of golf lessons shall be as approved and set forth by the Borough. All lesson money must be deposited into the point of sales system as it is collected. On a bi-weekly basis the lesson money will be paid to the golf instructor with a 90% payment to the golf instructor and 10% retained by the Borough.

Section 5. Qualifications. A current PGA of America member who possesses Class I status or is currently enrolled in the apprentice program with the expectations of completing the PGA of America Apprentice Program within five (5) years.

Section 6. No New Rights/No Vacancies. Unless expressly stated otherwise or required by law, this ordinance shall not create any rights that did not exist before this ordinance and this ordinance shall not be deemed to create any vacancies unless the law requires otherwise.

Section 7 Repealer. All prior ordinances that are inconsistent with this ordinance are repealed. All ordinances are hereby amended to be consistent with this ordinance and all ordinances, including this one, shall be construed consistent with the express purpose of this ordinance.

Section 8. Savings and Construction. This ordinance shall be construed consistent with the purpose stated in section 1 hereof. Any ambiguities in this ordinance shall be construed in accordance with the purpose of this ordinance.

If any part of this ordinance is invalidated by a court of competent jurisdiction, the remainder of this ordinance shall be saved to the full extent possible. This ordinance repeals provisions of the Borough Code only where stated herein; otherwise this ordinance is amendatory and supplementary to existing provision of the Borough Code.

Section 9. Codification. This ordinance shall be codified as an amendment to the salary ordinance and other chapters of the Borough Code, where necessary. The appendix to this ordinance shall not be codified but shall be available for inspection.

Section 10. Effective Date. This ordinance shall take effect immediately upon approval and publication of notice of adoption as provided by law.
