OUTDOOR DINING REGULATIONS

Effective Monday, June 15th, 2020

- Google shot of property, and/or a drawing or site plan showing location of outdoor seating area. Show number of tables & seating.
- What type of barrier/curbing protection proposed for dining tables to insure patron safety.
- Any table umbrellas must be secured & maintained.
- Any proposed tents will be required to submit a permit application to the Fire Prevention Office – to insure tents are secured properly.
- Any establishments along a main highway are recommended that seating be located away from the roadway and placed in rear or side areas, whenever possible.
- As per the Governor's order, please review the liquor license requirements.
- Must maintain social distancing rules & requirements outlined by Governor Murphy.
- Interior bathrooms must remain open for patrons.

COVID-19 PROTOCOLS FOR FOOD ESTABLISHMENTS OFFERING SERVICE IN OUTDOOR AREAS

- 1- POST SIGNAGE- NO ONE WITH FEVER OR SYMPTOMS OF COVID-19 SHOULD ENTER
- 2- SOCIAL DISTANCING- 6 FEET APART- SEATING- TABLES, WAITING AREAS, LINES FOR RESTROOMS TAPE ON FLOORS
- 3- NO BUFFETS , SALAD BARS, SINGLE SERVICE OPTIONS
- 4- DISINFECT ALL TABLES, CHAIRS, MENUS, CREDIT CARD MACHINES, KEYPADS AND COUNTERS
- 5- EMPLOYEES, FACE COVERINGS AND GLOVES, - CONDUCT DAILY TEMPERATURE CHECK,
- 6- REQUIRE INFECTION CONTROL PRACTICES, REGULAR HANDWASHING, COUGHING AND SNEEZING ETIQUETTE

REGULAR ROUTINE INSPECTIONS ARE BEGINNING TO TAKE PLACE- STARTING WITH THE MOST HIGH RISK ESTABLISHMENTS-
